Gentlemen:

In it's most ambitious effort yet, the UN and the Obama regime are working together to pass the Arms Trade Treaty to control and/or ban ALL PRIVATELY OWNED FIREARMS! The anti-gun nuts are holding secret meetings to craft a slew of uber-restrictive gun laws, known as the Arms Trade Treaty, against the will of We The American People.

Alan Gottlieb, Founder and Executive Director of CCRKBA (Citizens Committee for the Right to Keep and Bear Arms) and his wife Julianne Versnel, have been on the front lines fighting the anti-gunners at the UN. - Require micro-stamping on all guns.**
- Destruction of "excess" firearms.**
